Mobile ID is securely stored on the user's device only and is not stored in a central database. Only mobile ID holders can access their information using their biometric data or unique PIN, ensuring a trusted experience for both users and mobile ID verifiers. Users can also control the amount of personal data that is shared, so that a user who is asked to prove their age for an age-restricted purchase, for example, can reveal that they are over the required age, but not expose their full birth date, address or other personal information found on a driver license.
